in the research project "<u>Promoting biodiversity at the landscape level (KOOPERATIV)</u>". KOOPERATIV is funded in the Federal Program for Biological Diversity by the Federal Agency for Nature Conservation with funds from the Federal Ministry for the Environment, Nature Conservation, Nuclear Safety and Consumer Protection. The position should be filled **as soon as possible** not later than **01.03.2024** and it is limited **until 14.08.2028**. The salary is in accordance with the German public service salary scale (TV-L E13) with 75%, which corresponds to 29.85 working hours per week.

Your tasks

The transdisciplinary project is focusing on the ecological and economic outcomes of collaborative agri-environment measures and on the identification of supporting governance structures. The candidate will investigate the ecological effects of the established landscape-scale experiment that is represented by study landscapes along gradients of landscape diversity and shares of perennial flower fields in southern Lower Saxony, Germany. The main focus will be on the taxonomic and functional diversity of bees and hoverflies and the genetic population structure of bumblebees. Further, pollination services in oilseed rape fields will be analysed. The candidate will be involved in outreach and dissemination and contribute to general project tasks and activities.

- Completed university degree (Master's degree) in ecology, biology, agriculture or related disciplines
- Research focus on biodiversity, pollination ecology and ecosystem services
- Very good knowledge of ecological statistics (using R)
- Good knowledge of Geographic Information Systems (GIS)

- Experience in scientific writing and publishing

- Enthusiasm to conduct field work & interest in transdisciplinary collaboration
